CALIFORNIA NOTICE AT COLLECTION

FOR INDEPENDENT CONTRACTORS

This notice at collection for California residents is adopted in compliance with the California Consumer Privacy Act of 2018 ("CPRA"), as amended by the California Privacy Rights Act of 2020 ("CPRA"). Any terms defined in the CCPA/CPRA have the same meaning when used in this notice. This Notice applies only to independent contractors.

Information We Collect

Builders FirstSource, Inc. along with our subsidiaries and affiliates (collectively, the "Company") collects and uses Personal Information for contracting, health and safety, and business-related purposes and to be in legal compliance. Under the CCPA/CPRA, "Personal Information" means information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or household. It does not include publicly available information, lawfully obtained truthful information that is a matter of public concern, or consumer information that is deidentified or aggregate consumer information.

Below are the categories of Personal Information we may collect and the purposes for which we intend to use this information:

- Identifiers (e.g., name, date of birth, e-mail, job title, postal address, phone number, signatures, and other similar information).
- Protected classification characteristics of protected classifications under state or federal law.
- Financial account information (e.g., information for processing invoices billed to the Company, information in connection with payments made by the Company, and billing address and related information associated with payment method).
- Commercial information (e.g., records of personal property, products or services purchased, obtained, considered, or other purchasing or consuming histories or tendencies).
- Biometric information.
- Internet or other electronic network activity information, including, but not limited to, browsing history, search history, and information regarding a consumer's interaction an internet website application, or advertisement.
- Geolocation data, such as the location of company-issued laptops, mobile phones, or device location.
- Professional or other contractor-related information (such as contract requirements, information to satisfy contract requirements, experience, skills, work history, resume, certifications, licensure, background screening information (e.g., criminal and other public records and history; public court records; motor vehicle and driving records; or drug screening), applicable insurance policy coverage, professional registrations, emergency contact information, job title and role information, job status, technology usage, proposed and actual contracts, payment terms and other payment-related information (e.g., invoices, statements of work), bonuses, expenses, reimbursement, timekeeping and billing records, Taxpayer Identification Number (e.g., Employer Identification Number, Social Security Number), business registration or license number, tax forms (e.g., W-9, 1099-MISC) and other tax-related information, performance-related information and

- evaluations, insurance-related information, grievances, accidents and injuries, training, onboarding and offboarding information).
- Education information, defined as information that is not publicly available personally identifiable information as defined in the Family Educational Rights and Privacy Act (20 U.S.C. Sec. 1232g; 34 C.F.R. Part 99).

The Company may also collect "Sensitive Personal Information" for contracting, health and safety, and business-related purposes and to be in legal compliance. Below are the categories of Sensitive Personal Information we collect and the purposes for which we intend to use this information:

- Social Security, driver's license, state identification, or passport number.
- Account login, financial account, debit card or credit card number, in combination with any
 required security or access code, password, or credentials allowing access to an account.
- Precise geolocation.
- Information regarding racial or ethnic origin, religious or philosophical beliefs, sexual orientation, or union membership.
- Personal Information that reveals the contents of a consumer's mail, e-mail, and text messages in which the business is not the intended recipient of the communication.
- Biometric information for the purpose of uniquely identifying a consumer.
- Information regarding a consumer's health, such as information relating to health and safety in the workplace, accidents and near misses, and vaccination records and vaccination status information.

How the Company Uses Your Information

The Company collects Personal Information and Sensitive Personal Information to use or disclose as appropriate to:

- Comply with all applicable laws and regulations.
- Identify, evaluate, and determine eligibility of contractors for service engagements.
- To satisfy conditions of engagement in other contracts.
- Conduct background checks.
- Manage the contractor relationship with us, including for:
 - Onboarding processes;
 - To confirm conditions of engagement are met, including, as applicable, ensuring that contractor has appropriate insurance policies in place; the physical ability to safely complete service engagement, and perform other physical acts necessary to provide the services contracted for; and the technological ability to operate and navigate all technology and software necessary for the completion of assignments
 - Seek and process independent contractor arrangements;
 - Maintain and administer independent contractor payments;
 - Provide independent contractors with any data maintenance and support services
 The creation, maintenance, and security of your online account(s);
 - Reaching emergency contacts when needed, such as when you are not reachable or are injured or ill;
 - Claims management;
 - Service provider performance issues.
- Manage and monitor access to company facilities, equipment, and systems.
- Conduct internal audits and workplace investigations.

- Investigate and enforce compliance with and the potential breaches of Company policies and procedures.
- Engage in corporate transactions requiring review of contractor records, such as evaluating potential mergers and acquisitions of the Company.
- Maintain commercial insurance policies and coverages.
- Perform analytics, data analytics, and benchmarking.
- Administer and maintain the Company's operations, including for safety purposes.
- For marketing purposes.
- Exercise or defend the legal rights of the Company and its employees, affiliates, customers, contractors, and/or agents, as applicable.

As defined by the CCPA, the Company will not sell or share the Personal Information or Sensitive Personal Information that it collects.

Data Retention

The Company may retain your Personal Information and Sensitive Personal Information for as long as necessary to fulfill the purpose for which it was collected or to comply with legal or regulatory requirements. We strive to retain such information no longer than is reasonably necessary to carry out the purposes listed in this notice or as required by law. We retain your Personal Information and Sensitive Personal Information in accordance with applicable law and internal document retention practices.
